Terms of Agreement

CONTRACT: I am an independent contractor assuming all responsibility for money received as a result of my participation including but not limited to income tax, FICA, Workmen's Compensation and withholding taxes. I am not an employee or agent of Sprint Series of Nebraska.

BENEFITS: I agree that myself, heirs and assigns will be entitled only to the benefit of the Competitor Participant Accident Policy procured by the Series for accidental injuries or death which are the result of external, violent and visible means sustained in Series participation. The foregoing shall constitute the limit of liability of the Series for such injuries occurring to me in any Series events; I unconditionally release and indemnify the Series regardless of the cause and nature of the injury or death. I understand that I must obtain personal medical insurance in order to compete in any of Sprint Series of Nebraska's events.

COMPLIANCE: The undersigned agrees to abide by all rules and regulations of the Raceway and Series now or hereinafter promulgated. In consideration of the acceptance by the Series of this agreement, the undersigned recognizes his obligation to the public and the Series, which posts the prize money and conducts the event, and agrees to compete in all events when qualified if humanly possible.

BREACH & DAMAGE: In the event the undersigned breaches this agreement, he shall be liable for actual and liquidated damages sustained by the Series.
